Tar Heel Gem and Mineral Club – Proposed By-law Changes Effective Date for Review: September 16, 2025

The Board has reviewed the current by-laws and recommends the following changes. These updates are intended to provide clarity and consistency throughout the document.

We will present these at the meeting, ask for a nomination for change as written, request a vote and if approved, the changes take effect immediately.

# 1). Formally add the Technical Lead position to the by-laws and the following description of duties:

The **Technical Lead** is responsible for the following duties:

- **Smart Device Management**: Maintain and update the club's smart devices and accessories, ensuring full functionality prior to their use at club events.
- **Event Support**: Provide on-site technical support for smart devices during club events.
- Social Media Oversight: Manage the club's official social media account(s), including content posting and engagement. May assign additional admins as deemed necessary by the board.
- Ad Budget Management: Oversee the club's advertising budget for the annual show, as approved by the board.
- **Website Coordination**: Serve as an admin-level liaison with the club's webmaster to request updates or changes to website content based on board decisions.
- Meeting Participation: Expected to attend monthly club meetings and board meetings.

## 2). Update the current verbiage for nominations/voting for Board:

#### Rationale:

Our current by-laws lack clarity regarding the Board election process, particularly around the timeline and nomination procedures. Holding nominations in October and elections in November, while still allowing nominations on the night of the election, limits the Board's effectiveness and transparency. This compressed timeline restricts members' ability to thoughtfully consider candidates and undermines the integrity of the election process. A clearer, more structured approach will promote informed decision-making, encourage broader participation, and strengthen the leadership of the Board.

### **Current Verbiage:**

- A. The election of Club officers shall be held at the last monthly meeting of the year. Nominations shall be made from the floor. People can either be nominated by others, or self-nominated but actual acceptance of position must be done by the individual nominated for the position. Should more than one person be nominated for a position, the vote shall be by secret ballot and the candidate with the majority of votes shall be elected.
- B. The officers shall serve for one calendar year, and their duties shall begin immediately upon election.
- C. There shall be no limit to the number of terms an officer may serve.

## Requested Changes/Verbiage:

#### Club Officer & Board Member Election Process

#### 1. Nominations:

- Occur at the second-to-last monthly meeting of the year.
- Must be made from the floor.
- Individuals may be nominated by others or may be self-nominated.
- Nominees must personally accept the nomination to be considered.
- Nominees must be willing and able to accept the nomination and commit to the duties outlined in the bylaws.
- No nominations will be accepted at the last monthly meeting.

#### 2. Election:

- It will be held at the last monthly meeting of the year.
- If more than one person is nominated for a position:
  - o Voting will be conducted by a written, secret ballot.
  - o The candidate with the majority of votes is elected.




