#### **THGMC Board Nominations/Elections**

Are you considering running for a position on the THGMC Board? We want to help you make an informed decision! Below is a breakdown of each role, including estimated time commitments and responsibilities. Please review time commitments and expectations carefully before nominations begin at our **October 21 meeting**.

#### **Nomination Etiquette**

- Talk first: Always speak with someone before nominating them
- Be present: Nominees must attend the nomination and election meetings
- Be committed: Avoid "if no one else will..." nominations
- Be excited: Enthusiasm and readiness are key to success

### **★ General Expectations for All Board Members**

- Monthly Meetings: ~2.5 hours/month
- Board Meetings: ~2 hours/month
- Meeting Setup & Cleanup: Arrive by 6:30 PM; wrap up by 9:00 PM
- Annual Show Participation: Active involvement in planning and execution
- Communication: Timely responses to emails, texts, and calls

#### Board Positions & Time Commitments

#### President (5-10 hrs./month)

- · Presides over meetings and oversees club business
- Serves ex officio on all committees
- May create or dissolve committees with Executive Council approval

#### Vice President (2–4 hrs./month)

- Assumes President's duties when needed
- Becomes Acting President if the President resigns
- Supports other duties as assigned

#### Secretary (2–4 hrs./month)

- Distributes club communications (newsletters, announcements, etc.)
- · Records meeting minutes
- Manages membership periodicals
- · Supports duties assigned by the President

#### Treasurer (8–10 hrs./month)

- Manages club finances and reporting
- Authorizes expenditures (with President)
- Issues ID cards and transitions records to new Treasurer after elections

#### Member-at-Large (2-4 hrs./month)

- Two elected members serve on the Executive Council
- Support club initiatives and decision-making

#### **Technology Lead (2–4 hrs./month)**

- Smart Device Management: Maintain and update the club's smart devices and accessories, ensuring full functionality prior to their use at club events.
- Event Support: Provide on-site technical support for smart devices during club events.
- Social Media Oversight: Manage the club's official social media account(s), including content posting and engagement. May assign additional admins as deemed necessary by the board.

## Fluorescent Minerals-Adamite

What do you get when you mix a few rockhounds, a UV flashlight, and a rock? A whole lot of excitement!

Nature's ability to surprise and delight us is truly remarkable, especially when it comes to rocks and minerals that glow under ultraviolet (UV) light. These fluorescent specimens reveal hidden colors and patterns invisible in daylight, transforming ordinary stones into dazzling displays of natural science.

Whether you're exploring a curated collection or shining a blacklight on a freshly found specimen, the magic of fluorescence never gets old. It's science, it's art, and it's pure wonder—all wrapped up in a rock.

#### **Spotlight on Adamite**

On a recent buying trip to Franklin, North Carolina, the Club acquired some stunning specimens of **Adamite**, which will be available to members in the coming months.

Adamite is a rare zinc arsenate mineral, typically formed as a secondary mineral through the weathering of zinc- and arsenic-rich ore deposits. It's known for its vibrant hues—ranging from yellow green to brownish to colorless—and often forms in radiating or fan-like clusters.

At first glance, Adamite may appear to be just another brownish rock. Its shapes and formations might catch your eye, but the real magic happens under UV light. Shine a blacklight on it and **POW!** You'll witness its stunning luminescence, often glowing in brilliant lemon-yellow or bright green.

#### Why Rockhounds Love Adamite

- Chemical Composition:  $Zn_2(AsO_4)$  (OH) a zinc and arsenic-containing mineral.
- **Crystal Structure**: Prismatic or needle-like crystals, often forming aggregates, botryoidal masses, or crusts.
- Fluorescence: A vivid display under UV light, making it a favorite among collectors.

#### Where to Find Adamite

Adamite can be found in several locations around the world, including:

- Ojuela Mine, Mexico
- Tsumeb, Namibia
- Gold Hill, Utah

#### **Adamite Safety Tips**

Because Adamite contains arsenic, zinc, and sometimes copper, it's important to handle it with care. With proper precautions, it's safe for display and collection.

#### **Key Safety Guidelines:**

- **Toxicity**: Arsenic is poisonous, and Adamite is soluble in acids.
- **Dust Inhalation**: Avoid breathing in dust from Adamite—especially when cutting or polishing.
- Ingestion: Never put Adamite in your mouth or use it to make elixirs.
- Handling:
  - Wash hands thoroughly after handling.
  - Avoid creating dust.
  - Use a dust mask when cutting or polishing.
- Storage:
  - o Keep in a sealed container in a well-ventilated area.
  - Store out of reach of children and pets.

#### Other interesting Facts on Adamite

- Streak: White
- Hardness: 3½ on Mohs scale
- Tenacity: Very brittle
- Cleavage: Distinct/Good on {101}, good; on {010}, poor.
- Fracture: Irregular/Uneven, Conchoidal

- Meeting called to order at 6:58 PM
- Thomas Beach gave general club announcements
- Beverly House presented club by-law changes
- 1) Formally add the Technical Lead position to the by-laws and the following description of duties:

The Technical Lead is responsible for the following duties:

- Smart Device Management: Maintain and update the club's smart devices and accessories, ensuring full functionality prior to their use at club events.
- Event Support: Provide on-site technical support for smart devices during club events.
- Social Media Oversight: Manage the club's official social media account(s), including content posting and engagement. May assign additional admins as deemed necessary by the board.
- Ad Budget Management: Oversee the club's advertising budget for the annual show, as approved by the board.
- Website Coordination: Serve as an admin-level liaison with the club's webmaster to request updates or changes to website content based on board decisions.
- Meeting Participation: Expected to attend monthly club meetings and board meetings.
  - Motion to vote on changes by Davis Hall
  - Seconded by Kris Staska
  - Unanimous approval from all members
- 2). Update verbiage for nominations and voting for the board Current Verbiage:
- A. The election of Club officers shall be held at the last monthly meeting of the year. Nominations shall be made from the floor. People can either be nominated by others, or self-

nominated but actual acceptance of position must be done by the individual nominated for the position. Should more than one person be nominated for a position, the vote shall be by secret ballot and the candidate with the majority of votes shall be elected.

- B. The officers shall serve for one calendar year, and their duties shall begin immediately upon election.
- C. There shall be no limit to the number of terms an officer may serve.

#### Requested Changes/Verbiage:

#### **Club Officer & Board Member Election Process**

- 1. Nominations:
  - Occur at the second-to-last monthly meeting of the year.
  - Must be made from the floor.
  - Individuals may be nominated by others or may be self-nominated.
  - Nominees must personally accept the nomination to be considered.
  - Nominees must be willing and able to accept the nomination and commit to the duties outlined in the bylaws.
  - No nominations will be accepted at the last monthly meeting.
- 2. Election:
  - It will be held at the last monthly meeting of the year.
  - If more than one person is nominated for a position:
  - Voting will be conducted by a written, secret ballot.
  - The candidate with the majority of votes is elected.

Rationale: Our current by-laws lack clarity regarding the Board election process, particularly around the timeline and nomination procedures. Holding nominations in October and elections in November, while still allowing nominations on the night of the election, limits the Board's effectiveness and transparency. This compressed timeline restricts members' ability to thoughtfully consider candidates and undermines the integrity of the election process. A clearer, more structured approach will promote informed decision-making, encourage broader participation, and strengthen the leadership of the Board.


